High staff/volunteer-to-participant ratios in all programs ensure that physical, social and emotional skills are taught in safe, inclusive environments.

STAR City Programs (Skills Through Arts and Recreation) take place after school and weekends at community spaces in high priority neighbourhoods in Ottawa. Programs include art, basketball, STEM, Aikido, leadership training and so much more, giving vulnerable children and youth opportunities that they otherwise would not have.

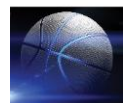

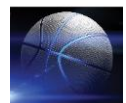

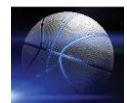
